### 1. SCDC Development Plans – new consultation – Have Your Say

The second consultation is still ongoing, but deadline to submit comments is **Monday 18<sup>th</sup> February 2013 5pm**. The public exhibitions have now ended, but there is a permanent one at the South Cambs offices in Cambourne which can be viewed during office hours. Main points to note:

(1) **Bennell Farm, Comberton**, but which is in Toft Parish is identified as having potential for development. It is an opportunity for Toft parish council to discuss and negotiate with Comberton parish council on how to approach this proposal to the mutual benefit of both communities.

(2) Land at Bourn Airfield, former TKA site, is being considered for

- (i) alternative types of employment use
- (ii) community stadium (but least favourite of the sites proposed for this facility)

(3) Caldecote and Toft have potential green spaces/recreation grounds to be designated for protection

(4) Correction to previous report – the development boundary of Comberton to be extended to include the remaining buildings in Comberton Village College that are not already included. This will NOT affect the Toft parish boundary. Also if Bennell Farm goes ahead, it will be in development framework of Comberton but remain in Toft parish.

### 2. SCDC Grants Review Update

SCDC Leader, Cllr Ray Manning, at his portfolio holder meeting last week, approved cuts to the grants budget for the next municipal year. Although the Leader agreed to have consultations, he chose unsurprisingly to ignore the useful suggestions that came out of it. So much for being a listening council!

Upshot is that

- funding for capital grants has been axed. There will be no grants from SCDC as from 1<sup>st</sup> April 2013. There is still some money in the pot, and any groups needing a grant should get their applications in to Joseph Minutolo by 28 February 2013. The community chest grants program will continue.
- 2. The CAB have a 2 year reprieve before their grant is removed
- 3. the grant that has supported the st-art programme (<u>www.start-arts.org.uk</u>) at our local village colleges has been removed though the Leader made a one off payment of £40 000 to give them breathing space.

The grantfinder service is still available from SCDC for assisting communities to search for grants nationwide. Contact Joseph Minutolo directly, or me and I will do my best to support the application.

## 3. Youth Council Launched

The South Cambridgeshire District Council (SCDC) Youth Council was formally launched on Wednesday 23<sup>rd</sup> January 2013. The Council received nominations from young people from across the district, and though 20 places were available, only 15 of them have been filled. The Youth Council will give young people in the district a chance to have a voice and to influence the decisions taken by the Council which will ultimately affect the development of their neighbourhoods. ## 5. Planning

- a. Caxton Gibbett: Planning approved to redevelop the old Yim Wah site. It will house McDonalds, Costa Coffee and Subway, creating up to 80 jobs.
- b. Plot 7, The Willows appeal is ongoing. Site visit postponed.
- c. Site East of Casa-de-Fosetta: Application for Lawful Development Certificate (LDC) refused.
- d. Banner Homes 18-28 Highfields Road, approach made to SCDC for pre-application talks.

## 6. Environmental Services

Service Fees and Charges Increase: The Environmental services portfolio holder has agreed to increase the fees that SCDC charges for some of its services. Those wanting additional or replacement black, green or blue bins will now be charged £69.50 (formerly £63.50). Stray dog kennelling fees have gone up from £12 to £15. Pest Control fees have also increased. Reason for increase is that charges will contribute to the efficient and cost effective delivery of a range of council services that impact directly on people's safety and health. #### Trial textile and shoe recycling collection service

A new textile recycling trial started at the end of January in South Cambridgeshire in an attempt to collect textiles and shoes and stop them ending up in landfill.

Households in Bar Hill, **Childerley**, Chittering, Dry Drayton, Knapwell, Landbeach, Longstanton, Swavesey and Waterbeach are in the trial.

Around 5,000 homes in the trial villages got blue recycling bags to put out spare clothing, shoes and household linen for collection alongside their blue bin. The first collection took place on Wednesday 30 January and will continue until further notice. If the trial proves successful, it will be rolled out to the rest of the district

# 7. Children's Centre Events

The advisory board meetings of Little Footsteps Children's Centre (of which I am a member) and Cambourne Children's Centre are being combined. The board members will remain the same for each centre, but the meetings will be held together. The first one was held on 18 January 2013.

# 8. Broadband – Connecting Cambridgeshire

The County Council Cabinet at its meeting on Monday 4<sup>th</sup> (which I attended), appointed BT as the supplier of superfast broadband to the County. It is a welcome decision, which gives hope to residents of South Cambs, but in particular those at Old Caldecote, Kingston and Toft, that they too will join the information superhighway. Contract will be signed in March and rollout planning will start after that. We don't know in what order the rollout will happen, so keep those registrations coming in to give us a good chance in getting it first. Please encourage your neighbours and friends to register or call me if they need assistance.

### 9. Broadband – BT Infinity for Highfields Caldecote

Superfast broadband seems to be crawling its way toward Highfields Caldecote! We are still waiting on BT to commission the PON (Passive Optical Network) that will get us on the information superhighway.
