#### **COVID19 UPDATE**

I am beginning to sound like a broken record on this topic, so I will keep it short and sweet. Omicron variant is now in the UK. Scientists are trying to grapple with its composition, how it transmits, its effects and all that. New Covid laws in place as of 04:00 on 30<sup>th</sup> November – masks must be worn on all public transport and in shops. Hospitality venues not affected. (2) All international arrivals must take day 2 PCR test and self isolate until they receive a negative result (3) all contacts of suspected Omicron cases must self-isolate for 10 days regardless of vaccination status. South Cambridgeshire now has the highest infection rate in Cambridgeshire County and increasing. Now stands at 562 per 100,000 as of 26<sup>th</sup> November. Cambridgeshire and Peterborough are still classified as an Enhanced Response Area (ERA) for at least the next week but I am expecting that the classification will be extended for a further period of time.

Please work from home if you can, if not, remember Hands-Face-Space-Fresh Air. If you have not been vaccinated, please do so now. If you need to get your booster, book it now or find one of the walk in centres. Taking a free rapid lateral flow test before a period of high risk will give you peace of mind that you are unlikely to be infectious with Covid-19 and it is unlikely you will spread the virus. ## **Transport**

The Greater Cambridge Partnership (GCP) is running a public consultation titled **Making Connections** -setting out ambitious plans to transform public transport, including a future bus network which would deliver faster, frequent and reliable bus services with cheaper fares The proposals, which are out to consultation until 20 December, include:

- Services running from 5am until midnight, with frequent buses to key destinations.
- More frequent services between 7am and 7pm, with buses every few minutes in the city, every 10 minutes from towns and larger villages, and hourly in rural areas.
- Express and direct services to the city centre, Cambridge Biomedical Campus, Cambridge Science Park and West Cambridge, and links to local rail stations.
- Small villages will have opportunities to 'plug into' the network through a regular connecting bus service, a demand responsive bus service, or access to a travel hub.
- Cheaper fares, such as a flat rate for trips in the city, daily and weekly tickets for regular users, hopper tickets, and cheaper family fares.

A transformed bus network could cost up to £40m per year to run and people are asked to consider how to both reduce congestion and raise funds to support such a scheme. Making Connections consultation closes at 12noon on Monday 20<sup>th</sup> December, whilst the Cambridge Eastern Access consultation closes at 12noon on Wednesday 22<sup>nd</sup> December 2021.

The Council Leader Cllr Bridget Smith attended COP26 in Glasgow last month and an opportunity to really see history in the making. She went as part of a Local Government Association delegation whose job it was to ensure that the final deal included the important role of local government including parish councils in getting us to Zero Carbon as quickly as possible. Also in attendance was Cllr Pippa Heylings in her role as Deputy Chair, Environment, Housing & Transport Board at LGA. In her speech to the conference, she made the case powerfully for including all tiers of local government to be acknowledged and included as playing a key role in the drive to resolve the climate crisis. It is within the powers of local government (parish, district and county) to reduce our carbon emissions by 30% so it is vital that we have the powers and the money to be able to do this.

## **Greater Cambridge Shared Waste (GCSW)**

The GCSW service has secured new funding (£50,000) for additional collection banks where residents can drop off small household electricals like kettles and toasters. Work has started to identify where these new collection banks will be. Did you know that households in Cambridgeshire are throwing away an average of 2.6kg of electrical items in their black bins each year!! It adds up to 320 tonnes of e-waste that could other wise be recycled. The banks are suitable for collecting most small items which have a plug or a battery, including phones, toys, kettles and many more. This year's Six Free Tree Scheme run by SCDC has been a success with applications from over 70 parish councils who could choose between 6 small trees or one whopper – so this year a total of 420 new trees will be planted. Combining this with the three free trees scheme run previously, over 580 trees have been offered to parish councils and community groups. We are keen to see the tree cover in south cambs increase as part of our journey to achieving net zero carbon. Trees play a very important role in that journey.

# **A428 Development Corridor Meeting:**

Took place as planned on 24<sup>th</sup> November 5.45pm to 8pm and was well attended by people from villages along the corridor and surrounding as far as Coton! The recording will be made available soon. Discussion centred around how the forum should be organised and a draft template Terms of Reference

# **Caldecote Liaison Meeting**

This quarterly meeting between Caldecote PC, Developers Linden and Balfour Beatty and Council officers took place on 17<sup>th</sup> November. A reminder that the meeting was set up to help mitigate any disruptive impact of construction on residents, promote the integration of new residents into the community, engage residents with the new development and the associated facilities. The Balfour development on Grafton Drive have completed the show home, and have 2 new houses occupied at front of site in October. They are on target for end 2022 completion due to national shortage of labour and materials supplies. The minimal signage to the development was discussed and BB confirmed they are only allowed 2, but trying to get a more prominent one. Linden Homes not in attendance. However we know they have also had new occupations at the front of the site and their show homes were completed a few months ago.
